### **Weigh Ins:**

All weigh- ins will be done remotely by your club. Coaches are responsible for adding in wrestlers weights on Friday, January 16th from 5pm-11:59pm. Tournament Director will email coaches the weigh in link and password. Late registrations will need to email weight to Tournament Bracketing Director before Saturday, January 17th@ 12pm. Those wrestlers with no weights by Saturday January 17th @ 12pm may be scratched from the tournament and forfeit their entry fee. Random Weight Checks will be done onsite. Any clubs with wrestlers not within 5% of submitted weight will be penalized.
